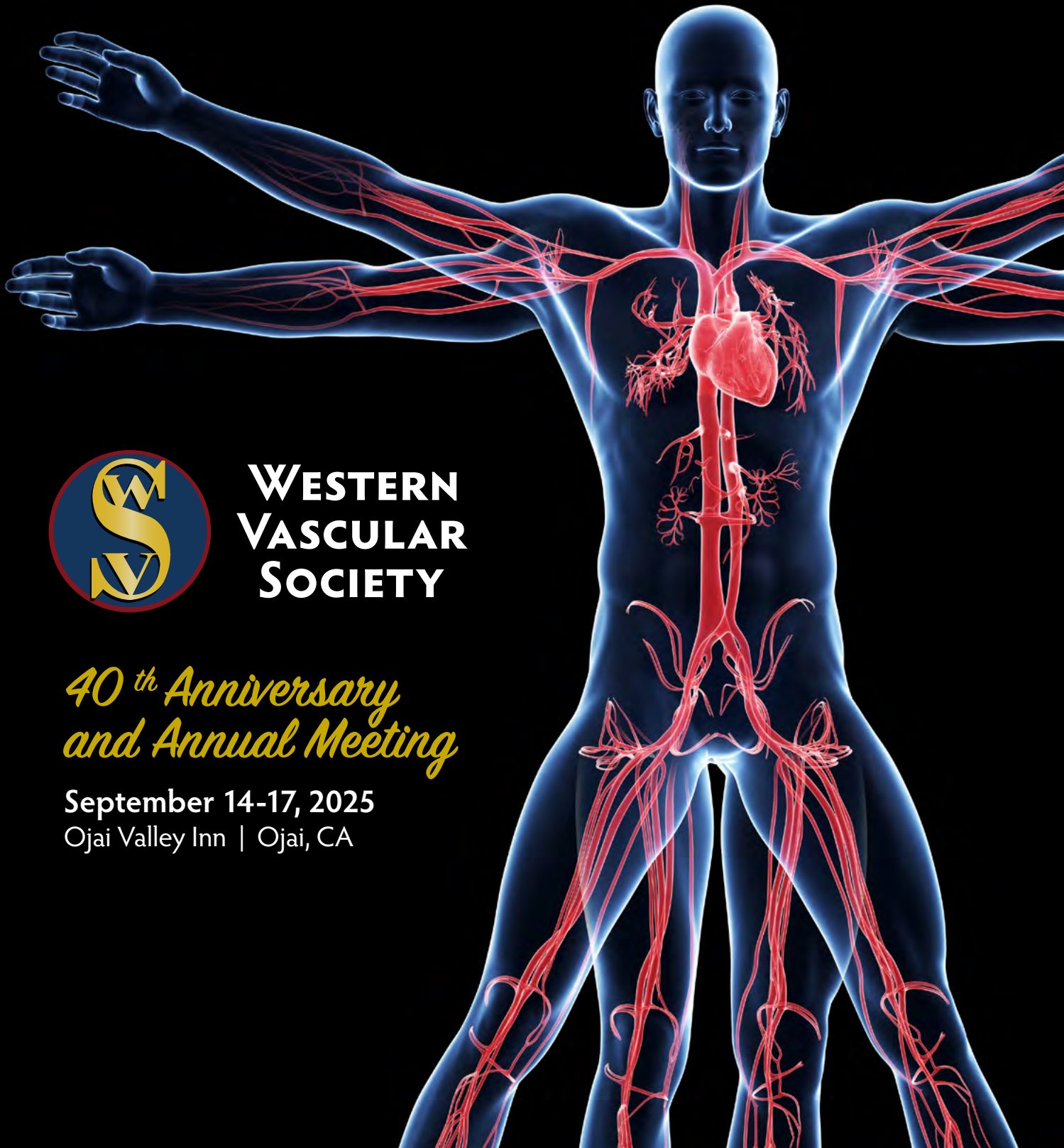

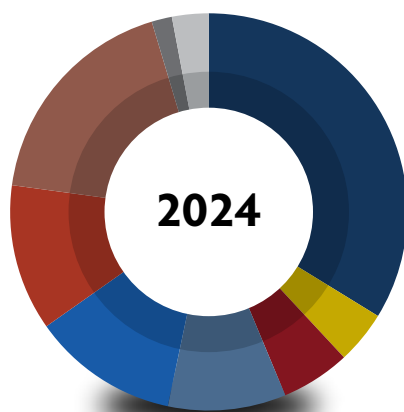

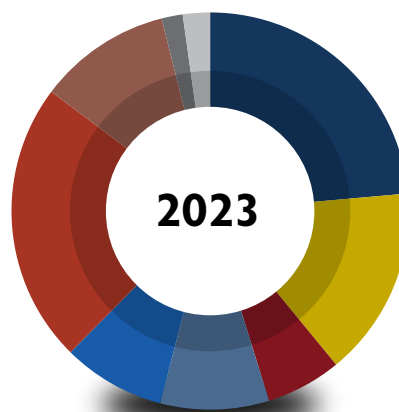

Entertainment or Social Activities/ Unofficial Satellite Events

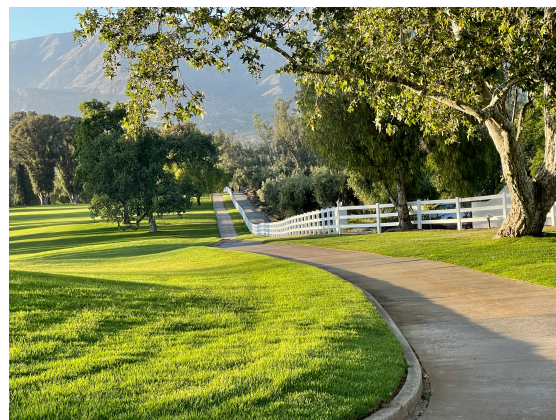
